

# PUBLIC NOTICE

## TOWN OF NEWINGTON

### Mosquito Control

Mosquito Control begins the week of April, 2017 in the Town of Newington. Crews from Dragon Mosquito Control will be checking swamps, marshes, woodland pools, ditches, storm drains and other shallow, stagnant water for mosquito larvae. When mosquitoes are found, the following insecticides may be used:

VectoBac ( <i>Bacillus thuringiensis israelensis</i> )	BVA 2 Mosquito Larvicide Oil (mineral oil)
Natular (spinosad)	CocoBear MLO (mineral oil)
Altosid (methoprene)	AquaBac 200G ( <i>Bacillus thuringiensis israelensis</i> )

A truck mounted sprayer will disperse Duet (sumithrin & prallethrin) or Zenivex (etofenprox) along roadways and private properties (unless property owner notifies town otherwise). Road spraying may begin in June and continue into October as necessary. It is not possible to predict the schedule for road spraying in advance. The spray schedule is based upon mosquito surveillance data, disease test results and weather conditions.

If Eastern Equine Encephalitis or West Nile Virus is found in or near Newington, then emergency spraying may be conducted using one or more of the following products:

Cross Check Plus (bifenthrin)	Permanone (permethrin)
Duet (sumithrin & prallethrin)	Zenivex (etofenprox)
DeltaGard (deltamethrin)	
Essentria IC <sup>3</sup> (rosemary oil, geraniol, peppermint oil)	

Emergency spray treatments may be conducted at the following locations:

Newington Public School	Town Hall
Police Station	Fire Station
Tennis Courts	Ball Field
Town Garage	Fox Point
South Newington Basketball Court	Old Town Hall
Old School	Carter's Rocks Park
Cemetery	Recreation Area
Transfer Station	Library

It is not possible to predict if emergency spraying will be necessary. The spray schedule is based upon mosquito surveillance data, disease test results and weather conditions. Further communication will be given if emergency spraying is going to take place.
